SECTION 4: First aid measures

4.1. Description of first aid measures

General information	Get medical attention immediately. Show this Safety Data Sheet to the medical personnel. Chemical burns must be treated by a physician.

5.3. Advice for firefighters

Protective actions during firefighting

It is the user's responsibility to satisfy himself as to the suitability of such information for his own particular use.
